

Main Event Passport Rules and Regulations

1. The Main Event Passport qualifier will run May 23-July 3, 2011. Entrants will have the opportunity to qualify for a package worth \$13,000 (thirteen thousand US Dollars). Once a player qualifies they have the option to choose one of the following Main Event packages:
 - o WSOP* Main Event - \$13,000 deposited into player's account;
 - o EPT London Main Event –package is currently worth \$13,750 and it includes EPT London Main Event seat, accommodation, expenses and a seat into the £550 NLHE side event;
 - o PCA Main Event (seat, hotel, expenses) – this package is worth \$14,500;
